


WHAT WE MAKE



Soil

We produce **Inoculated Aged Arbor Wood Chip Mulch**. Mulch like this has successfully improved the soil in 100+ year-old vineyards run by our founder for over a decade, and has been tested by other, nearby grape growers. Demand is rising! We will soon scale up and begin to expand its use by ranchers and others.

The beauty of this product is its simplicity. We need only be allowed to let it pile up within the mutually agreed-upon safe parameters and work with the natural conditions to cultivate mycorrhizal fungi spores on the surface of the amply-sized wood chips.

As Feedstock, this aged and inoculated wood mulch requires solely the biomass produced from chip machines in the Tree Trimming (Arborist) Industry. That's it - 100%!


This single parent material is abundantly available and needs to be removed from the waste stream. Doing so will mitigate the risks (mainly from fire, smoke and poor air quality) that arise when these wood chips are not disposed of safely and responsibly.



WHAT WE MAKE

Carbon

This mulch material is completely nontoxic, from the moment it is gathered and stored on our premises and as it ages. The natural carbon deposits become enriched by fungal spores through a proprietary process that increases farmland's resistance to heat and wind and reduces water requirements to grow crops when used as a substrate.



Because of its unique carbon sequestering properties, this becomes a valuable and much-needed soil amendment for the agriculture industry. We keep more carbon in the ground instead of releasing it into the atmosphere or to produce methane in landfills.



Farmers who use this product will be eligible for carbon credits, an important revenue stream that will compensate them for successfully reducing greenhouse gas emissions by restoring carbon to the soil (i.e. carbon farming).

Management

We do the legwork and paperwork for farmers who use our product to receive these credits, offering a short path to alignment with 21st century climate mitigation policies.

Branding their food as *Grown in Primordial Biome*TM (the commercial name we are testing for this mulch) will help our client farms differentiate themselves from less-sustainable competitors by being forward about their "planet first" ethos.



HOW WE MAKE IT

- We use a static mounding system whereby the piles wick moisture from the ground.
- The wicking relies on the wood chip piles resting on porous ground. Soil compaction is not required and does not occur. Furthermore, there are no nitrates to manage.
- Study results show that this process keeps soil and groundwater safe and does not leach contaminants.
 Data proving this has been validated by reputable private labs.
- The process of cultivating fungi on the woodchips approaches biomass as an asset to be harvested and achieves the goal of fuel reduction going into fire season.




OVERVIEW OF LAB RESULTS

Better than Compost

Testing at Biome Makers / Bayer Crop Science and Soil Control Lab shows Primordial Biome sequesters dramatically more carbon than other soil amendments such as biochar and compost and that the carbon retention ability persists for more than five years. Additional, exhaustive testing was recently performed at Biome Makers / Bayer Crop Science on multiple test plots.

- Fungal taxonomy and species analysis by Biome Makers Inc found 47% (out of 50% possible) of the fungal species are carbon fixating. (By comparison, the carbon fixating species in typical compost ranges from 20 to 30%.)
- Soil nitrogen supply testing by Biome Makers Inc. shows that 72% of the bacteria contained in Primordial Biome provide inorganic nitrogen release. This is considered a top tier value and is comparable to soil amendments such as animal manure compost, which has a similar bacterial composition -- but does not have all of the contaminant problems of manure.



Microbially Rich

 Biodiversity testing by Biome Makers Inc. found high microbial diversity with 11 species of bacteria and 33 distinct species of fungi. In particular, Primordial Biome contains 12 species of fungi listed on the coveted California Dept of Food and Agriculture Approved Microorganisms list.



OVERVIEW OF LAB RESULTS

Nontoxic

• Significantly, Soil Control Laboratories' analysis found nothing about Primordial Biome that was toxic to the environment. Leachates such as nitrogen compounds were considered too low in concentration to compute a ratio. Other environmental contaminants such as salmonella, fecal coliform, and heavy metals are at the lowest end of the safest range.

Cucumber seedling emergence is considered a fail safe measure of toxicity because of the intense sensitivity of these seedlings to toxins.

Out of 100 cucumber seedlings 100 plants emerged.



Both the Maine Soil Testing Service at the University of Maine and Biome Makers, Inc. found
that when Primorial Biome was topically applied to soils with no tillage, the microbiology in the
mulched wood chips unlocked the potential within the soil -- raising nearly all nutrient levels to
optimal or above optimal levels.

Drought Protective

According to data from the National Resource Conservation Service, a federal agency:



This product has the potential to reduce required water use by as much as **27,000 gallons per acre** in vineyards.
