

[PROPOSED] ORDER TO SHOW CAUSE REGARDING PLAINTIFFS' APPLICATION FOR TEMPORARY RESTRAINING ORDER AND PRELIMINARY INJUNCTION

TO DEFENDANTS:

DEFENDANTS EMILY CUTRER, MILDRED GARCIA, SONOMA STATE UNIVERSITY, and THE CALIFORNIA STATE UNIVERSITY BOARD OF TRUSTEES ARE ORDERED TO APPEAR before the Honorable Judge English, Judge of the Superior Court of the State of California, County of Sonoma, at the Courthouse located at 3055 Cleveland Ave. Santa Rosa, CA 95403, Department 18, on at 2000; to show cause why a preliminary injunction should not be issued against Defendants, preliminarily enjoining them from taking any further action to implement or effectuate the January 22, 2025 Decision by Interim President Emily Cutrer, including but not limited to reallocating fees currently dedicated to the athletic department, canceling Sonoma State Athletic teams' membership in either the California Collegiate Athletic Association or the National Collegiate Athletic Association, or requiring students to change majors.

The Court has reviewed the Ex Parte Application for a Temporary Restraining Order and Preliminary Injunction filed by Plaintiffs on April 10, 2025, along with the supporting declarations and exhibits, and arguments of the parties during the April 14, 2025 hearing.

GOOD CAUSE APPEARING THEREFOR, IT IS HEREBY ORDERED:

- 1. Defendants, and all persons acting on Defendants' behalf or in concert with them, are restrained and enjoined, pending hearing on this Order to Show Cause, from taking any further action to implement or effectuate the January 22, 2025 Decision by Interim President Emily Cutrer, including but not limited to reallocating fees currently dedicated to the athletic department, canceling Sonoma State Athletic teams' membership in either the California Collegiate Athletic Association or the National Collegiate Athletic Association, or requiring students to change majors
- 2. Plaintiff shall serve this Order on Defendants no later than 4 (16 (2005)
- 3. Any opposition to the issuance of a preliminary injunction shall be filed and served by 4/26/205.

 Any reply by Plaintiffs shall be filed and served by 4/26/205.
