1 **TO DEFENDANTS:**

2 DEFENDANTS EMILY CUTRER, MILDRED GARCIA, SONOMA STATE UNIVERSITY, and
3 THE CALIFORNIA STATE UNIVERSITY BOARD OF TRUSTEES ARE ORDERED TO APPEAR
4 before the Honorable Judge English, Judge of the Superior Court of the State of California, County of
5 Sonoma, at the Courthouse located at 3055 Cleveland Ave. Santa Rosa, CA 95403, Department 18, on
6 5/1/2025 at 9:00am, to show cause why a preliminary injunction should not be
7 issued against Defendants, preliminarily enjoining them from taking any further action to implement or
8 effectuate the January 22, 2025 Decision by Interim President Emily Cutrer, including but not limited
9 to reallocating fees currently dedicated to the athletic department, canceling Sonoma State Athletic
10 teams' membership in either the California Collegiate Athletic Association or the National Collegiate
11 Athletic Association, or requiring students to change majors.

12 The Court has reviewed the Ex Parte Application for a Temporary Restraining Order and
13 Preliminary Injunction filed by Plaintiffs on April 10, 2025, along with the supporting declarations and
14 exhibits, and arguments of the parties during the April 14, 2025 hearing.

16 **GOOD CAUSE APPEARING THEREFOR, IT IS HEREBY ORDERED:**

- 17 1. Defendants, and all persons acting on Defendants' behalf or in concert with them,
18 are **restrained and enjoined**, pending hearing on this Order to Show Cause, from taking any
19 further action to implement or effectuate the January 22, 2025 Decision by Interim President
20 Emily Cutrer, ~~including but not limited to reallocating fees currently dedicated to the athletic~~
21 ~~department, canceling Sonoma State Athletic teams' membership in either the California~~
22 ~~Collegiate Athletic Association or the National Collegiate Athletic Association, or requiring~~
23 ~~students to change majors~~ WITH RESPECT TO THE DISCONTINUATION
24 & ELIMINATION OF ACADEMIC PROGRAMS. (K-60)


- 25 2. Plaintiff shall serve this Order on Defendants no later than 4/16/2025
26 3. Any opposition to the issuance of a preliminary injunction shall be filed and served by
27 4/21/2025. Any reply by Plaintiffs shall be filed and served by 4/23/2025.
