

# NOTICE OF A SONOMA COUNTY BOARD OF SUPERVISORS VIRTUAL PUBLIC HEARING TO RECEIVE AN INFORMATIONAL UPDATE ON THE SONOMA DEVELOPMENTAL CENTER SPECIFIC PLAN PROJECT

This Notice of Virtual Public Hearing was issued during the Sonoma County Shelter in Place order.

**WHO:** Project Applicant, County of Sonoma, **Permit Sonoma File No. 2020-1084**

**WHAT:** This Sonoma Developmental Center (SDC) Specific Plan informational update will provide an opportunity for staff to update the public and the Board of Supervisors on the status of the development of the SDC Specific Plan. The update will include an overview of the Background Reports, an update on visioning efforts for the site, and a summary of input from various stakeholders. This discussion will serve as a forum for additional input on the development of Vision Statement and Guiding Principles as well as key issues to be considered in preparation of various Specific Plan concepts on a 945-acre site surrounding the main campus, which is located at 15000 Arnold Drive, Eldridge, CA (APN 054-090-001, 054-150-005, 054-150-010). **Supervisorial District 1.**

**The Sonoma County Board of Supervisors** will hold a virtual public hearing to hear project updates and receive public comment, which will support the project team in drafting a Specific Plan. All interested persons are invited to attend and provide comments. **Members of the Public May Not Attend this Meeting in Person.**
