19 The District Attorney of the County of Sonoma, State of California, hereby accuses the  
20 above named defendant of the following criminal offenses:  
21

22 COUNT 1

23 On or between April 1, 2020 and October 22, 2020, in the County of Sonoma, State of California,  
24 the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was committed in that  
25 DAVID CHRISTOPHER COOK did willfully, unlawfully, and lewdly commit a lewd and  
26 lascivious act upon the body of JANE DOE, a child under the age of fourteen years, with the intent  
27

1 of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said Defendant,  
2 DAVID CHRISTOPHER COOK and the said child (The first time, he put her hand on his  
3 penis).

4 COUNT 2

5 On or between April 1, 2020 and October 22, 2020, in the County of Sonoma, State of California,  
6 the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was committed in that  
7 DAVID CHRISTOPHER COOK did willfully, unlawfully, and lewdly commit a lewd and  
8 lascivious act upon the body of JANE DOE, a child under the age of fourteen years, with the intent  
9 of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said Defendant,  
10 DAVID CHRISTOPHER COOK and the said child (The second time, rubbing her butt).

13 COUNT 3

14 On or between April 1, 2020 and October 22, 2020, in the County of Sonoma, State of California,  
15 the crime of Lewd Act Upon A Child in violation of PC288(a), a Felony, was committed in that  
16 DAVID CHRISTOPHER COOK did willfully, unlawfully, and lewdly commit a lewd and  
17 lascivious act upon the body of JANE DOE, a child under the age of fourteen years, with the intent  
18 of arousing, appealing to, and gratifying the lust, passions, and sexual desires of the said Defendant,  
19 DAVID CHRISTOPHER COOK and the said child (The last time, rubbing her butt).

22 NOTICE: Conviction of these offenses will require you to register pursuant to Penal Code section  
23 290. Willful failure to register is a crime.

25 NOTICE: Pursuant to Penal Code Sections 11166 and 11168, a Suspected Child Abuse Report  
26 (SCAR) may have been generated in this case. Penal Code Section 11167 and 11167.5 limit access  
27 to a SCAR. A protective order issued by a court is necessary to obtain a copy of the report.

1 NOTICE: The above offenses are a serious felony within the meaning of Penal Code Section  
2 1192.7(c) and a violent felony within the meaning of Penal Code Section 667.5(c)

3 NOTICE: Conviction of these offenses will require the court to order you to submit to a blood test  
4 for evidence of antibodies to the probable causative agent of Acquired Immune Deficiency  
5 Syndrome (AIDS). Penal Code Section 1202.1.

6  
7 NOTICE: Conviction for these offenses may require you to provide specimens and samples  
8 pursuant to Penal Code Section 296 if you are convicted of a felony offense or have a prior  
9 qualifying offense in your criminal background. Willful refusal to provide the specimens and  
10 samples is a crime.

11  
12 NOTICE: PURSUANT TO PENAL CODE SECTION 29810(a)(1)

13 NOTICE: Conviction of this offense will require you to relinquish all firearms you own,  
14 possess, or have under your custody or control in the manner provided in Penal Code section 29810.

15  
16 NOTICE: PURSUANT TO PENAL CODE SECTION 29810(a)(2)

17 NOTICE: Conviction of this offense will prohibit you from owning, purchasing, receiving,  
18 possessing, or having under your custody or control any firearms, ammunition, and ammunition  
19 feeding devices, including but not limited to magazines.

21 MARSY'S LAW

22 Information contained in the reports being distributed as discovery in this case may contain  
23 confidential information protected by Marsy's Law and the amendments to the State of California  
24 Constitution Section 28. Any victim(s) in any above referenced charge(s) is entitled to be safe and  
25 free from intimidation, harassment, and abuse. The defendant(s), defense counsel, and any other  
26 person acting on behalf of the defendant(s) is admonished not to use any information contained in  
27 the reports to locate or harass any victim or the victim(s)' family and to not disclose any


1 information that is otherwise privileged and confidential by law. Additionally, it is a misdemeanor  
2 violation of Penal Code Section 1054.2(a)(3) to disclose the address and telephone number of a  
3 victim or witness to a defendant, defendant's family member, or anyone else. Note exceptions  
4 provided in Penal Code Section 1054.2(a)(1) and (2).

5       Discovery Request: Pursuant to Penal Code Section 1054.5(b), the People are hereby  
6 informally requesting that defense counsel provide discovery to the people as required by Penal  
7 Code Section 1054.3.

8       Complainant therefore prays that a warrant issue and that said defendant be dealt with  
9 according to law. I declare under penalty of perjury under the laws of the State of California, based  
10 on information and belief, that the foregoing is true and correct.
